In order to become a good water steward, we are working to reduce the amount of water we use in our operations, but also to regenerate and preserve water use, to protect local water sources for future generations. For that reason, TCCEC is committed to work with key stakeholders to address the issue of water management at a local level, but it also believes that Government has to take the lead in establishing over-arching water policies within which TCCEC and other water users can operate.

TCCEC is committed to Improve water efficiency in its manufacturing sites by 20% by 2030 (compared to a 2015 baseline), to Replenish 100% of the water we use in areas of water by 2030, through community-based partnerships and finally it is committed to develop its business practices in a way that is aligned with Alliance for water stewardship standard. Water is a key ingredient in our products and essential to our manufacturing processes. It is necessary that we ensure water quality, as per our food safety standards, as well as sustainable supply. Our Action on Water helps to support UN Sustainable Development Goal 6 on Clean Water and Sanitation.
